

Karl Jaspers (1883~1969)

- Existentialism: "What can a human being be is ultimately hidden in his freedom. As long as he lives there must be something that he should be able to obtain through constant efforts that he makes. His dignity is that he represents something that cannot be defined."
- Transcendental Value: "Ultimately what remains is the human being that does not lose love when thrown into destruction, and still maintains mysterious trust to the basis of things. Beyond all codes, thoughts reach to silence fulfilled by unlimited basis."



- "The question of German Guilt" was published in German "Die Schuldfrage" in <u>April 1946</u>.
- It constitutes legal, moral and philosophical basis for what Germany did under Nazi.

Jaspers and Axial Age




- "The Origin and Goal of History" was published <u>in 1949</u> in German, translated to English in 1953.
- Axial Age as defined by Jaspers: 500 B.C.: China, India, West (Iran, Palestine, Greece)

Axial Age in the 21st Century?

- America (Euro-America) is the leading status-quo actor.
- China is the powerful challenging actor.
- Is this a civilizational collision or coexistence?
- Are there other actors?
- Yes, there are!







Origin of Japan's philosophy



- ~400 BC = Jomon Era
 = Japan's Axial Age
- Wood, rocks, rivers, mountains, stars
- 538 Buddhism from China → coexistence of Shinto and Budda
- 9th Century → Grass and trees, national Soil, all turning into Budda → 13th Century Zen

Russia and Japan = Comparative Analysis of History of Identities



- Japan developed its civilizational position at the border of Chinese, and Russia at the border of Byzantine.
- Russia in the early 18th, Japan in the mid-19th century faced serious "Westernization".
 Contradiction continues.

Civilizational Message from Japan

- Accepting foreign culture as it is; creating something of our own; share with the world
- 1st flow=From China; Edo 260 years; readiness to face foreign European powers
- 2nd flow=From Europe; fast rise to create Imperial Japan; ultimate failure at WWII
- 3rd flow=From America; Economic rise of Showa; what are we creating now?

Overcoming Tribalism in Japan Responding to Amy Chua

- Ethno-singularity; rice-pad agriculture; nation-wide shared tradition and culture
- Old-tribalism= Ainu in Hokkaido;
 Okinawa's present-day differentiation on American military bases
- New-tribalism = immigration and refugees.
 Will Japan accepts more foreigners and live harmoniously with them?
